# Sex Offender Registration Act Training

<u>Course Overview:</u> This course is designed to show officers how to proactively use sex offender registration and restriction violations as an intelligence and street level enforcement tool. This program will provide students with a standardized approach to conducting address verification checks and investigating sex offender complaints within their communities while addressing problems or issues specifically related to sex offender registration or restriction investigations.

### **Course Objectives:**

- Sex offender and violent offender registration terminology
- Sex offender and violent offender registration process and forms
- The application of sex offender registration violations at the federal level
- Notification issues and special considerations regarding sex offenders
- Notification to school officials and other aspects of community notification and record keeping

<u>Instructor:</u> Tracie Newton has served as the Program Manager for the Illinois State Police Offender Registration Unit since 2005. In her current role, she ensures that all information placed on the Illinois State Police Sex Offender Registry and Murderer & Violent Offender Against Youth Registry is correct, as well as notifying registrants of their violations, providing training throughout the state and reviewing all offender registration legislation introduced to the Illinois General Assembly.

MTU#10 Law Enforcement members who are under the <u>mandate</u> requirements will be given priority on state mandated courses and then MTU#10 local members. If it is <u>not a mandated</u> course, all MTU# 10 local members will be given registration preference until seven days prior to the date of class. After that date, registrations will be taken on a first-come, first-served basis, regardless of MTU status. We cannot accept registrations from individual officers. All registrations must go through your Chief, Sheriff, or department training office, even if you are attending class on your own time.
