All registrations must go through your Chief, Sheriff, or department training office, even if you are attending class on your own time.

<u>Cancellation</u>: If a class must be canceled for any reason, every effort will be made to do so at least 2 weeks before the class is scheduled to begin. However, there are circumstances where last minute cancellation is out of our control. All officers who have been registered for training will be contacted at the email address given at registration, so please be sure to provide an email address which is checked often.
