COURSE DESCRIPTION: This instructor development course is designed to assist in the development of law enforcement officers who can return to their organizations as instructors and subject-matter experts. Attendees will increase their ability and effectiveness to instruct others within a practical law enforcement-specific context. Students in the course will be expected to conduct two "teach backs" of learned and designed material to the instructor(s) and classmates, as well as develop their own lesson plan. Students must conduct the teach-backs and pass a written exam to complete the course successfully.

Attendees will also be taught classroom instructional methods and how to effectively teach academic and physical skills to adult learners relevant to the dynamic police operational environment and their agency needs. This is an interactive course where students actively participate in the learning environment created by experienced instructors.

COURSE OBJECTIVES:

- Identify the goal of creating a teaching model to successfully and effectively train police officers to perform competently in a law enforcement field context.
- Understand and apply the concepts of adult learning.
- Recognize and understand the characteristics of adult learners.
- Identify and apply validated instructor competencies to guide the planning, development, delivery, and assessment of instruction of adult learners.

- Identify and develop methods to effectively teach physical skills to adult learners that promote optimal performance in a law enforcement context.
