Kevin is an Assistant Adjunct Professor at St. Mary's University of Minnesota, where he teaches public safety courses. He is also an instructor for Northwestern University's Center for Public Safety, in Evanston, Illinois, where he teaches supervisory, command, and executive-level programs. He also serves as a course director for the School of Police Staff and Command. Kevin has taught throughout the United States and lectured on American Policing at the Garda Síochána (Irish National Police) Academy.

**COURSE DESCRIPTION:** This 3-day course provides newly appointed field training officers with the tools to be able to effectively evaluate subordinate personnel.

**Non-Member Tuition:** \$240.00. Non-Member tuition shall apply to civilians, officers from State/Federal agencies, and officers from Local Law Enforcement agencies which are not a member of any MTU. Tuition will be invoiced to departments upon course completion. If a pre-registered student from a Non-Member agency fails to attend training, and the agency fails to provide advance notice within 7 days of the start date of that class, the agency will be invoiced the entire amount of the student's tuition.

**To Register:** Registration must be completed online via [www.letac.org](http://www.letac.org). MTU #10 local member department officers will be given registration preference until seven days prior to the date of class. After that date, registrations will be taken on a first-come, first-served basis, regardless of MTU status. We cannot accept registrations from individual officers. All registrations must go through your Chief, Sheriff, or department training office, even if you are attending class on your own time.

**Cancellation:** If a class must be canceled for any reason, every effort will be made to do so at least 2 weeks before the class is scheduled to begin. However, there are circumstances where last minute cancellation is out of our control. All officers who have been registered for training will be contacted at the email address given at registration, so please be sure to provide an email address which is checked often. Cancellations will also be posted to our mailing list and our Facebook and Twitter accounts.
