*Procedural Justice (17hrs), Use of Force: De-escalation Techniques (6.5hrs) – Scenario (6.5hrs),
Officer Safety Techniques (2hrs) – Scenario (1hr)*

Course overview: A four-day training course to certify instructor candidates on techniques and procedures for teaching AR15 patrol rifle at their home agencies as both initial user and sustainment training option. The comprehensive curriculum is focused on student teaching skills with multiple teach-backs incorporated into each day. The course culminates with instructor candidates preparing and teaching a half day range as in-service range training format presented to guest student base.

Course goals will include:

- Instructor candidates gain skills needed to conduct end-user training for entry level operators and sustainment training for their agency.
- Instructor candidates are able to conduct classroom led blocks of instruction on fundamental core skills including use of dummy rounds.
- Instructor candidates are able to competently conduct range operations in a safe and effective format.
- Instructor candidates develop a block of instruction using a written lesson plan that includes a teaching format and range session.
