## Patrol Carbine/Patrol Rifle Instructor Course

**Meets Illinois Mandates: Procedural Justice (17hrs), De-escalation Techniques (6.50hrs + 6.50hrs Scenario) and Officer Safety Techniques (2.00hrs + 1.00hrs Scenario)**

**COURSE OVERVIEW:** A four-day training course to certify instructor candidates on techniques and procedures for teaching AR15 patrol rifle at their home agencies as both initial user and sustainment training option. The comprehensive curriculum is focused on student teaching skills with multiple teach-backs incorporated into each day. The course culminates with instructor candidates preparing and teaching a half day range as in-service range training format presented to guest student base.

- Ammo: (50) Rounds Pistol

### **Prerequisites Required for Enrollment!**

The Patrol Rifle Instructor class is not a beginner's course. It is not designed to teach students new to the operation of the patrol rifle. The content of this class is structured to qualify you to instruct others.

Students must have completed a patrol rifle end user course and be proficient with the functioning and use of the patrol rifle. Additional rifle training courses and personal practice will aid your success in this class.

All students will be required to complete an initial qualification shoot on the first day of class. Students will be given two chances to successfully pass this shoot. Those who fail to pass will be dismissed from the course.

We strongly encourage you to practice this course of fire prior to the class.

### **PATROL RIFLE INSTRUCTOR PRE-TEST CARBINE**

Takes place at 15 yards; has 4 parts; has a 6 second par time for every part 15 rounds total: 14

Rifle, 1 Pistol / Rifle Magazines Loaded 12 and 2

**PART 1:** Start position LOW READY, carbine on safe. At buzzer: fire 5 rounds into score box.

**PART 2:** Start position HIGH READY, carbine on safe. At buzzer: fire 5 rounds into score box.

**Part 3:** Start from LOW or HIGH READY, carbine on safe. At buzzer: fire 2 rounds rifle into score box, TRANSITION TO PISTOL, 1 round PISTOL into score box. Finish the drill with a loaded rifle.

**PART 4:** (Set up round in chamber of rifle and empty magazine in gun) Start from LOW or HIGH READY, carbine on safe. At buzzer: fire 1 round, BOLT LOCK RELOAD, 1 round into the score box.

**POSSIBLE 15/15 INTO SCORE BOX.**

**ALL SHOTS MUST BE ON SHEET OF PAPER.**

ANY SHOT OVER TIME IS -1, SUBTRACTED FROM THE FINAL SCORE

**MINIMUM PASSING SCORE AFTER ANY DEDUCTIONS IS 10/15**
