COURSE OVERVIEW: Law enforcement officers' role in the community includes a variety of interactions, including responding to incidents with individuals with mental health concerns or diagnosed mental illness. This 8-hour class is geared to enhancing law enforcement officers' awareness of mental health issues by providing information on the history of mental health system, types of mental illnesses, signs and symptoms of each, and common treatments and medications. It will also cover situations that law enforcement may experience on a regular basis and considerations when responding to individuals, their families, and service providers.

COURSE OBJECTIVES: Definition of mental illness and mental health, Common forms of mental illnesses and the symptoms and behaviors associated with each, Treatment options, Appropriate L.E. interactions with mentally ill individuals, their families & service providers and, how to respond to crisis situations involving the mentally ill.
