# Solo Officer Response- Rapid Deployment

**This course has been approved and certification for the following mandates: Active Threat Response, Civil Rights, De--escalation Techniques, Law Concerning Stops, Searches and the Use of Force and, Officer Safety Techniques, Including Cover, Concealment, and Time.**

**Course overview:** This one-day, 8-hour instructor course is designed to train officers to perform solo officer response rapid deployment/immediate action tactics. The focus of this program will be to provide officers with the knowledge and specialized tactical skills to perform solo officer rapid deployment/immediate action.

**COURSE DESCRIPTION:** Rapid deployment/immediate action is the swift and immediate deployment of law enforcement resources to a life-threatening active threat situation. These situations require immediate action and the rapid deployment of law enforcement. Failure to act has catastrophic consequences resulting in death and/or great bodily harm to innocent people.

These incidents may also necessitate the immediate and rapid deployment of personnel to contain and prevent the escape of an armed and dangerous offender, or rescue a downed officer and/or civilian. Topics to be addressed include:

- Individual movement
- Individual room clearing tactics
- Use-of-force and safety priorities
- Equipment and identification requirements
- Linking up with other first responders and integration of other personnel and agencies
- Verbal skills
- Deployment and firearms handling

**COURSE GOALS:** The goals of this course are as follows:

- To review and study workplace and school shooting incidents, including a detailed debrief of numerous recent incidents where solo officer response rapid deployment tactics have been applicable and utilized.
- To provide students with an understanding of why solo officer response rapid deployment/immediate action techniques were developed and the need for them to be integrated into law enforcement tactics.
- To assist participants in developing an awareness of the critical elements which constitutes an active threat and when the use of solo officer response rapid deployment/immediate action tactics are appropriate and necessary.
- To identify and discuss use-of-force and safety priority issues related to rapid deployment/immediate action incidents, including immediate defense of life, law, police, procedure, and established safety priorities.
- To provide students with an inventory of appropriate equipment to be used when conducting these types of operations, including issues related to weapon and ammunition selection and uniform/identification requirements.
- To assist participants in demonstrating practical knowledge and ability while performing solo officer response movement techniques, room clearing, verbal skills, firearms handling/deployment skills, and actions upon contact.
- To allow students the opportunity to participate in realistic scenario-based training and demonstrate their ability to perform solo officer response rapid deployment/immediate action critical skills.

**COURSE PREREQUISITES:** Sworn law enforcement officers currently employed by a unit of government. While not mandatory, it is suggested that departments enroll officers in this program that have had previous instruction in basic tactical pistol and patrol rifle skills and have passed the 24-hour “Rapid Deployment” End User Course. This is a dynamic, fast-paced course geared towards officers who already have a basic knowledge of tactical firearms handling/deployment and patrol tactics.

**Instructor:** **Bruce Liebe** is a 30-year veteran of law enforcement, serving 25 years with the Illinois State Police. With the ISP, he was assigned to the Tactical Response Team (SWAT) for 13 years, serving as statewide program coordinator, assistant team leader and entry team member. At retirement, he was assigned as deputy chief of staff in ISP’s Division of Operations. He served as an assistant professor of homeland security and senior director of the School of Professional Studies and at MacMurray College in Jacksonville, Illinois. He is a member of the National Tactical Officers Association and the Illinois Tactical Officers Association. Bruce is a featured author for the National Tactical Officers journal, *The Tactical Edge*, where he has contributed 21 articles to date centering on tactical training, tactical program administration, and operations planning and management. He consults internationally on these topics.

Liebe presently operates Paladin Tactical LLC which offers training and consulting services. He is certified by the Illinois Law Enforcement Training and Standards Board as an Active Threat Master Instructor and is certified by

All registrations must go through your Chief, Sheriff, or department training office, even if you are attending class on your own time.***
