**Course overview:** This 8-hour, voluntary training program was created as a review for officers who have at least one year's experience as an active CIT officer. Participants in this course will review topics such as trouble shooting, legal updates, self-care, and community resources. They will also partake in valuable group exercises in de-escalation and active listening and review and refresh their skills in realistic scenario role play exercises.

**Please note:** Officers are required to have 1 year of experience as an active CIT officer.

**Instructors:** The course will be conducted by a diverse group of law enforcement and behavioral health professionals, including active CIT officers from various parts of the State of Illinois. An essential part of the CIT course is scenario-based skills training with crisis scenarios provided by trained professional actors. All scenarios are facilitated and evaluated by certified CIT officers.
