# Investigating Social Networks and Cell Phone Applications

### **Course Overview:**

The decisions made by the Patrol Officer and/or Detectives who can either make or break a case which involves sensitive internet/digital investigation. This 16-hour program will address the ability of investigations response which is crucial in the handling of complaints and investigations related to internet-based crimes, i.e. Fraud, Sexting, Cyberbullying, Sex Predators, Stalking etc.

### Upon completion of the training exercises, participants will:

- Obtain the basic overview of various social networks and what information they possess.
- Understand how computer / cell phone forensics work
- We will understand how to access the Law Enforcement Portals for social networks
- Obtain crucial information in Internet/Social Network Cases.
- Understand how to obtain IP's, screen names, email headers, Social Network user I.D. and Cell Phone data for the investigation.
- We will learn how to do subpoenas and search warrants for these various social networking sites.

- The student will learn about the Electronic Communications Privacy Act (ECPA)
- Various laws concerning Internet Crime such as Computer Tampering, Stalking, Computer Fraud, Identity Theft, Harassment through Electronic Communication, Sexting, Indecent Solicitation of a Child, Sexual Exploitation of a Child and Child Pornography.

To Register: Email registration to register@letac.org. You may also fill out and submit our online registration form through the website at www.letac.org or call 217-726-7014 to register by phone (be sure to include all pertinent information). MTU#10 Law Enforcement members who are under the mandate requirements will be given priority on state mandated courses and then MTU#10 local members. If it is not a mandated course, all MTU# 10 local members will be given registration preference until seven days prior to the date of class. After that date, registrations will be taken on a first-come, first-served basis, regardless of MTU status. We cannot accept registrations from individual officers. All registrations must go through your Chief, Sheriff, or department training office, even if you are attending class on your own time.

**Cancellation**: If a class must be canceled for any reason, every effort will be made to do so at least 2 weeks before the class is scheduled to begin. However, there are circumstances where last minute cancellation is out of our control.
