Course overview: This course is designed with the detective or patrol officer investigating death, and coroners or medicolegal death investigators in mind. This course will specifically discuss scene processing, last known re-enactments, witness and family statements, evidence collection and documentation, injury and wound interpretation, investigative techniques as they relate to child and infant death and the multi-disciplinary approach to reviewing these cases. This course contains photography of real scenes and pathology evidence.

Darren holds national certification as a Medicolegal Death Investigator through the American Board of Medicolegal Death Investigators (ABMDI), as well as being a nationally certified criminal investigator and certified criminal investigations instructor.

Non-Member Tuition: \$80. Non-Member tuition shall apply to civilians, officers from State/Federal agencies, and officers from Local Law Enforcement agencies which are not a member of any MTU. Tuition will be invoiced to departments upon course completion. If a pre-registered student from a Non-Member agency fails to attend training, and the agency fails to provide advance notice within 7 days of the start date of that class, the agency will be invoiced the entire amount of the student's tuition.

If it is not a mandated course, all MTU# 10 local members will be given registration preference until seven days prior to the date of class. After that date, registrations will be taken on a first-come, first-served basis, regardless of MTU status. *We cannot accept registrations from individual officers. All registrations must go through your Chief, Sheriff, or department training office, even if you are attending class on your own time.***

Cancellation: If a class must be canceled for any reason, every effort will be made to do so at least 2 weeks before the class is scheduled to begin. However, there are circumstances where last minute cancellation is out of our control. All officers who have been registered for training will be contacted at the email address given at registration, so please be sure to provide an email address which is checked often.
