## Preventing Targeted Violence

Course Overview: The phenomenon of active shooters in our schools and public areas are at an all-time high. The goal MUST be to identify and intercept the criminal activity and intervene before the threat is able to implement their plan. However, many school administrators and LEOs minimize the pre-event postings of the active shooter. The reason these postings do not receive adequate attention is a lack of training and understanding of social media and internet investigations. This class will train law enforcement how to gather digital evidence against an aggressor so they may find out who the perpetrator is and act after the comment or posting is made. Students will learn the fundamentals of investigating social media and internet related crimes, using the Electronics Communication Privacy Act to their advantage to identify the person responsible for the posting BEFORE their plans are carried out.

Instructor: Det. Rich Wistoki (Ret.) Has been in Law Enforcement for 30 years with 28 years of it with Naperville Police Department. He was a Youth Investigator, member of the Cyber Crimes Unit, a SWAT Sniper, and an expert in Defensive Tactics. He is the author of the State Cyber Crimes Law, who also served on the DCFS Death Review Team (96-02). He conducts several other trainings, such as NASRO, IL MTU, Suburban Law Enforcement Academy, NCJTC, ICAC, ILETSB Firearms Instructor, SWAT Defensive Tactics Instructor and ASP Trainer.
