### BASIC PATROL RIFLE – END USER

**Meets Illinois Mandates: De-escalation Techniques (1.50hr + 1.50scenario), Law Concerning Stops, Searches, and the Use of Force (0.50hr) & Officer Safety Techniques, Including Cover, Concealment & Time (8.00hrs + 8.00scenario)**

**COURSE OVERVIEW:** Upon completion of this training, the officer will understand all aspects of rifle function, including the cycle of function, operation, carrying and deployment of the patrol rifle. This will include proper carry orientation, i.e., loaded condition of the patrol rifle. Instruction will include proper handling of the patrol rifle, including loading, unloading, clearing malfunctions, and accurately firing the patrol rifle. Also included in this training will be techniques for transitioning to and from the duty handgun with the patrol rifle (transition drills). Additionally, students will be instructed in proper movement and bounding with the patrol rifle. Students will also be taught how to utilize proper cover and concealment when deploying the patrol rifle. Students will also be taught how to clean, inspect, and function check the patrol rifle, as part of the broader overall maintenance of the rifle.
