This course is based on a modified "San Jose" program common in most departments. Many of the topics will also apply to a variety of different FTO programs

**COURSE GOALS:** \*Demonstrate the Q6 performance Leadership Model to achieve higher levels of collaboration \*Demonstrate aligning personal & organizational goals to maximize subordinate performance \*Identify subordinates collaborative ideology to increase a vested interest for the organizations success \*Demonstrate the various leader-producer levels to inspire greater achievement in subordinates \*Identify knowledge & experience to cultivate independence in subordinates \*Discuss leadership development among subordinates \*Discuss legal updates impacting organizational progress in an ever-changing landscape.
