## **Reid Investigative Interviewing & Advanced Interrogation**

**COURSE PURPOSE:** This Course will enhance the investigator's ability to assess a subject's credibility - to read and evaluate the verbal and nonverbal behavior symptom displayed by a subject (victim, witness or suspect) during an investigative interview for indications of truth or deception. It will expand the content of the investigative interview by demonstrating the utilization of behavior provoking questions and the appropriate response models. It will increase the investigator's ability to secure legally acceptable confessions through the use of the Reid Nine Steps of Interrogation, including theme development, stopping denials, overcoming objections and the use of alternative questions. This program combines the content of the 3-day Reid class as well as the 1-day Advanced Reid class.

COURSE GOALS: After completing this four-day course, The Reid Technique of Investigative Interviewing & Advanced Interrogation Techniques, the attending officer(s) will be able to – Identify the distinguishing characteristics between an interview and an interrogation \*Properly set up an interview room \* Identify and recognize the behaviors suggestive of a truthful subject with respect to their Attitude, Posture, Use of Illustrators, Displacement Behaviors, Eye Contact, Verbal responses and Paralinguistic behaviors, Properly Phrase the Behavior Provoking questions, as well as a host of many other techniques.
